### **FORM OF INDEMNITY - INDIVIDUALS**

IN CONSIDERATION of IMERY'S MINERALS LIMITED of Par Moor Centre, St. Austell, Cornwall, PL24 2BB and THE ST AUSTELL BAY BOAT CLUB ("the Companies") permitting **SABBC members** to enter the Company's land at **Par Harbour** from **1<sup>st</sup> January 2024** until further notice for the purpose of Launching/Mooring.

I the undersigned hereby agree:-

1. (i) To indemnify and hold harmless the Companies and their employees from and against any claim
  - (a) for injury or death where the said purpose is mainly recreational or educational or for my/our commercial benefit without commensurate benefit to the Companies; or
  - (b) in all other cases for injury or death unless and to the extent that such injury or death was caused by the negligence of the companies or their employees; and
  - (c) in all cases for loss of or damage to any property whatsoever, arising as a result of my/our presence on the Companies' land.

- (ii) Unless otherwise agreed, to report to the Local Manager or his authorised representative upon arrival and again upon departure and to obey any lawful instruction from the said Local Manager or his authorised representative whilst on the Companies' land.

- (iii) That all activities shall at all times be carried on in accordance with the Health and Safety at Work etc. Act 1974, and all other relevant regulations or enactments in force for the time being.

2. (i) That entry onto and passage over the Companies' land is at my expense and, subject to 1(i)(b) above, at my/our risk.

- (ii) That this permission operates only to authorise entry on/between above mentioned date(s).

That this permission does not authorise the removal of any stone, mineral, growing plant or other item or substance from the Companies' land.

That this permission is personal to me and may not be transferred to any other party.

That this permission does not operate to authorise visits by unaccompanied persons under 18 years of age

- (iv) That I am responsible for any persons accompanying me who are under 18 years of age.

- **I have received a Health and Safety induction.**
- **I have read and agree to abide by all club rules.**
